RE: Upcoming FID Proposition 218 Election

Dear FID Landowner,

For over 100 years, Fresno Irrigation District (FID) landowners like yourself have invested in a legacy of water by financially contributing to infrastructure, facilities, and supply to support the production of bountiful crops, local jobs, and community growth.

Continuing this legacy will require further investments in activities that increase water supply capture and delivery efficiency; build infrastructure to help make the District drought resilient; and protect and defend local water rights for the future. At its Board meeting on January 12, the Board of Directors unanimously approved proceeding with a Proposition 218 election in 2023. As an FID landowner, you will be asked to vote in an upcoming Proposition 218 election to assist in these key areas. Ballots to vote in the election will be mailed to your parcel address in April.

Benefits of the increased investments will be focused in three key areas:

- Surface water infrastructure: Both new and improved water delivery infrastructure and services including necessary upgrades to aging infrastructure, to make sure we get water where it needs to go to your farms and businesses.
- Groundwater sustainability: We plan to continue building new recharge basins
 and adding interties to as many existing basins as possible. We must continue
 progress towards achieving the benchmarks of the Sustainable Groundwater
 Management Act (SGMA) and other regulatory programs. Not only does this keep
 local control over our groundwater supply, but it also helps stabilize the local
 groundwater table.
- Legal and water rights defense: There are active threats against our water rights.
 FID will be enabled through Prop 218 investments to continue to protect and defend our area's precious surface water supplies against both existing and future threats.

To continue FID's next century of service, the Proposition 218 election proposes an initial Water Service Rate increase in 2024 to \$89/acre with additional increases over time to reach \$128.75/acre in 2028*. This equates to \$35.60 per acre-foot of water delivered in

2024 which remains some of the lowest rates when compared to neighboring irrigation districts.


WHAT IS MY ROLE AS AN FID LANDOWNER?

PROPOSED ASSESSMENT

FID is proposing an initial Water Service rate increase in 2024 with gradual increases through 2028. For detailed information and a rate classification breakdown, review FAQs or the Engineer's Report on our website. FID will use assessment dollars to develop and maintain surface water infrastructure and protect the legacy of our landowners through action on drought, regulation, and existing threats to our Kings River water rights and future water rights battles.





EXCEPTIONAL WATER SUPPLY CONTINUES TO BENEFIT OUR LANDOWNERS

FID holds one of the strongest water supply rights on the Kings River, and on an annual average runs a four-to-five-month delivery of nearly 500,000 acre-feet.

Despite facing the driest
3 years on record across
California, FID made
irrigation deliveries with a
3-month run in 2020, 1-month
in 2021, and 3-month in
2022.

Not all districts can say they have delivered irrigation water during the driest times.

Fresno Irrigation District landowners have direct influence over the legacy of their land and our area's water supply. Prop 218 elections require the support of voters – FID landowners – to invest in activities that increase water supply capture and delivery efficiency, make us drought resilient, and protect local water rights.
