SUBJECT: Award of Contract for the Siskiyou Avenue Rehabilitation – Whitesbridge to Kearney, Federal Project No. STPL-5291(033) to Cal Valley Construction, Inc. (JG)

RECOMMENDATION: Council by motion adopt the resolution:

1. Awarding the contract for the Siskiyou Ave. Rehabilitation – Whitesbridge to Kearney, Federal Project No. STPL-5291(033) to Cal Valley Construction, Inc. in the amount of \$1,019,569.85; and
2. Authorizing a 10% construction contingency in the amount of \$101,956.00; and
3. Authorizing the City Manager to sign the construction contract on behalf of the City; and
4. Authorizing the City Manager to sign change orders, up to the additional contingency amount, on behalf of the City.

EXECUTIVE SUMMARY:

The Siskiyou Avenue Rehabilitation (Project), Federal Project No. STPL-5291(033), will consist of the rehabilitation of the existing pavement on Siskiyou Avenue from Whitesbridge Road to Kearney Boulevard. The work will consist of: 1) dig out and reconstruction of pavement areas with structure failure; 2) grind and pavement overlay of areas where the pavement surface is showing significant cracking and weathering; 3) fog seal placement over the entire pavement surface. The Project will also include the replacement or construction of various concrete improvements where they are currently damaged or non-compliant with ADA accessibility guidelines.

The Project will additionally construct improvements in vicinity of the Siskiyou Avenue pavement rehabilitation limits for taking advantage of the cost value resulting from having Cal Valley Construction, Inc. perform the work under one construction contract. The additional work will consist of: 1) construction of a raised crosswalk at the intersection of San Joaquin and Park Avenues; 2) removal and reconstruction of failed concrete infrastructure on Kenneth Avenue, north of California Avenue; 3) dig out and reconstruction of pavement areas, and removal and reconstruction of failed concrete infrastructure in the area bounded by Whitesbridge Road and Del Norte, California and Kenneth Avenues.

On August 21, 2024 the City advertised a request for bids with four contractors submitting by the September 11, 2024, 3:30 PM deadline. The results are as follows:

Staff has reviewed the bid submitted by Cal Valley Construction, Inc. Based on the review, staff has determined the bid received to be responsive and Cal Valley Construction, Inc. to be a responsible contractor.

FISCAL IMPACT:

The total estimated Project cost is \$1,364,462, including design, construction, construction management, and contingency. The Siskiyou Avenue construction portion of the Project, \$912,883.85, will be funded with \$780,588 in Federal Surface Transportation Block Grant (STBG) funds and the required local match of \$132,295.85 from Local Transportation Funds. The remainder of the Project construction, outside of the Siskiyou Avenue limits, \$106,686, is not eligible for STBG funding and will be funded with Local Transportation Funds. There are sufficient Local Transportation Funds budgeted in the FY 24/25 Budget to cover the required local match and the work outside of the Siskiyou Avenue limits of work.
