SUBJECT: Dia De Los Muertos Parade Request(s) (JAJ)

RECOMMENDATION: City Council consider a resolution approving a request by Kerman Rotary Club to conduct a parade in conjunction with Rotary's Dia De Los Muertos Day festival and waive up to \$1000, or an amount to be determined by City Council of in-kind staff and equipment costs - with possible direction to staff.

EXECUTIVE SUMMARY:

In 2023, the Kerman Rotary Club produced a local festival in recognition of Dia De Los Muertos.

This year on November 2, 2024 the Kerman Rotary Club proposes to expand the festival with longer hours, greater participation and a proposed parade. It was demonstrated with the smaller event last year that the event was very successful and delivered significant community benefit by providing a cultural and family-friendly event honoring Hispanic heritage.

The City has reserved Kerckhoff Park for the Rotary Club's use, but the request to add a parade requires City permission, permits and greater coordination. The proposed parade is estimated to have up to 50 entries representing car clubs, motorcycle clubs, walkers, bands and floats from throughout Fresno County.

Coordination of a parade involves greater city involvement and potential resources. Public safety, traffic control and public inconvenience all need to be taken into consideration. It is recommended that city staff be involved to ensure public safety and it is estimated that traffic control equipment and staff time for support may total \$2,000. Of that amount, staff recommends that the City Council adopt a resolution, **Attachment 'A'**, to waive up \$1,000 of those costs or an amount as determined by City Council, with Rotary Club of Kerman reimbursing the City for the remaining balance of City expenses.

The proposed parade route is shown in Attachment 'B'.

Representatives of the Kerman Rotary Club have been invited to attend the October 9, 2024 City Council meeting to provide further detail on the proposed parade and address questions of the City Council.
