SUBJECT: Approving Sale of Additional Surplus Vehicles and Equipment (JA)

**RECOMMENDATION:** Council by motion adopt resolution approving the sale of additional

surplus equipment and vehicles.

#### **EXECUTIVE SUMMARY:**

On August 9, 2023, Council adopted Res 23-65 approving the sale of surplus property.

Since the approval of the surplus items in August, the City has received newly purchased vehicles; with the arrival of the new vehicles, staff has identified additional equipment and vehicles as surplus.

Approval of the additional items will allow staff to include vehicles and equipment in the publicized surplus sale.

The vehicles and equipment surplus sale dates are set for October 30, 2023 through November 3, 2023, and will be published according to the guidelines set forth in the Purchasing Policy.

If sale items do not receive bids or offers to purchase, the Purchasing Officer will proceed with the appropriate method of disposition listed as "Donation" in Section D. 5 of the Purchasing Policy.

Increase to General and Vehicle Funds.
