1. Accessory Dwelling Unit Program (ADU Program):

The Accessory Dwelling Unit Program was approved by Council. Mr. Orozco shared and provided additional information to the Planning Commissioners. Each ADU will be plan checked on a case-by-case application. The intent is to provide cost aid for homeowners. Commissioner Bandy asked if each ADU will require its own path and address. Mr. Orozco shared that each ADU requires a lighted path and address. Commissioner Brandy also asked if there is a limit of ADUs per lot. Mr. Orozco responded each lot will be allowed one ADU and one junior ADU. A junior ADU is attached to the primary home. Commissioner Jones asked if the lot has to meet a size requirement. Mr. Orozco responded that there is no lot size requirement, as long as the ADU meets the setbacks requirement no applicant can be denied. Commissioner Bishop asked if the public has shown any interest in building an ADU. Mr. Orozco shared that no applications have been submitted yet, but people have requested information regarding the ADUs.

2. Upcoming Planning Commission Appointments:

Mr. Orozco shared that the Planning Commission terms expire at the end of December 2022. There will be two vacant chairs: Chairperson and Vice Chairperson. The filing deadline will be Friday, December 16, 2022. Mr. Orozco would like to present all nominees to City Council in January 2023.
