SUBJECT: Resolution Accepting the Kerman Northwest Park Project and Authorizing Filing of the Notice of Completion (JG)

RECOMMENDATION: Council by motion adopt resolution accepting the Kerman Northwest Park Project and authorizing the City Engineer to record the Notice of Completion.

EXECUTIVE SUMMARY:

The contractor, Amercian Paving Co. has satisfactorily completed the work required for the Kerman Northwest Park (Project). The Project consisted of 1) grading and earthwork; 2) installation of electrical facilities; 3) construction of concrete sidewalk; 4) installation of a 2" water service; 5) installation of landscape irrigation and planting and; 6) installation of trash receptacles.

In order to close out the Project, City Council must accept the improvements and authorize the recording of a Notice of Completion.

The Project was advertised for bid and the construction contract was awarded to Amercian Paving Co., on August 9, 2023. The Contractor began construction on November 13, 2023, and completed the Project on October 30, 2025. The Project was completed within the specified contract time.

FISCAL IMPACT:

The City budgeted \$918,500 for the Project. The estimated final Project cost is \$855,000 including design, construction management, inspection, and contingency. The Project is funded with California Department of Parks and Recreation Prop 68 per Capita Grant Funds and Local Match Funds.
