LN: Mentioned the last discussion being about designs and asked which mural locations were approved. TJ stated the two locations that were selected were the wall along La Ramada facing south and Valley West Property Building facing south as well. The Kerman Letters will go on the La Ramada wall and the historical depiction will be on the Valley West Property. After Rec Commission suggestions, changes were sent to CC and projects began. LN asked if there is an ETA. TJ stated one location still needs to sign the agreement. TJ also reached out to the artists to let them know the agreements have been approved and when they are going to be ready for install. Estimated installation is early 2025.

MT: Asked what the original cost estimate was for Hart Ranch Park in the beginning. TJ mentioned initially was estimated at \$7-8 million project.

MT: Asked what were the contests on the first round of bids. TJ mentioned there were two protests. Questions were regarding the skills of the contractors, specifically the experience in installing water features. The other protest was that one of the contractors didn't clarify where they are getting the dollar amount for one of the items they bid. and that contingency money was being used, where does it allow that.

IH: Shares commends Jesus Gonzales and TJ for keeping HRP moving. also suggests looking to future projects when these next to projects complete. Remaining comments were inaudible.

LN: asked about new city entrance. Did the theme change from saving water to veterans? TJ stated yes, city manager decided the change the theme to something less controversial since we are not currently in a drought.

MT: Mentions a trail system would be great and asked if we can work with Planning Commission to incorporate the trail from initial planning phase. IH stated that that's a great plan and we can make better plans by getting all aspects of planning involved. TJ mentioned that the previous Community Development director was holding project development meetings. As tentative track maps world come in, staff would review and provide feedback. During two meetings attended, trails were suggested for those tracks.
