This letter is to confirm the North Central Fire Protection District's plan to transfer staffing from Station 56 (Kearney Park) to the future Station 53 once the new station is operational.

At its meeting on February 23, 2023, the Board reviewed and supported the relocation of Station 56 to the Howard and Kearney Boulevard area. This move is aimed at improving emergency response times, strengthening service delivery in the growing areas of Kerman, and ensuring compliance with NFPA standards. The Howard and Kearney site was selected based on its strategic position to better serve the community, including the industrial district south of the railroad tracks.

Escrow for the property at Howard and Kearney officially closed on June 27, 2025, securing the site for future development and long-term service planning.
