SUBJECT: Implementation of AB 413 through Curb Markings and Installation of No Parking Signage to Enhance Pedestrian Safety and the Quiet Enjoyment of Residences (JAJ & SW)

RECOMMENDATION: Council by motion adopt resolution approving and authorizing curb markings and no parking zones as follows:

- 1. At priority crosswalks and corners adjacent to school sites and other locations as deemed necessary for pedestrian safety and in conformance with AB 413; and
- 2. Posting of "No Parking and No Truck Parking" signage along North and South Siskiyou Ave and West Kearney Blvd. in residential zones areas to enhance public safety and convenience.

BACKGROUND:

Several locations have been reported and identified as requiring curb markings and "No Parking" signage to improve vehicular, bicycle and pedestrian safety.

Further, Assembly Bill 413, effective January 1, 2025, prohibits drivers from parking "within 20 feet of the vehicle approach side of any unmarked or marked crosswalk." The bill also bans parking 15 feet from a crosswalk with a curb extension as generally depicted in **Exhibit 'B'** to the proposed resolution.

Pursuant to Kerman Municipal Code Chapter 10.12, "at such times as the Chief of Police finds that the public safety and convenience require the establishment of no parking or limited parking zones for motor vehicles on the public streets in the city, he shall report this fact to the City Council at a meeting of that body." Such report is made via this Staff Report and at the Council meeting.

DISCUSSION:

Since passage of Assembly Bill 413, City Departments, including Police, have publicized and worked to educate the public about the new safety law, yet compliance has been inconsistent and unsatisfactory.

In order to better inform drivers and to enhance pedestrian safety, curb markings are now recommended in specific locations and areas focused on school sites and high uses areas.

Additionally, the City prohibits the parking of heavy duty, non-emergency vehicles and semi-truck tractor trailers in residential areas. With new residential growth occurring, new areas of the City require installation of "No Truck Parking", signage to enforce violations in those newer areas primarily along North and South Siskiyou Avenues and eventually West Kearney Blvd.

For future implementation beyond the immediate urgent need, the City Engineer will design a "Standard Detail" to be incorporated into the *City's Design Standards* for public and private improvements to detail specifications for installation of curb markings to "daylight" crosswalks as dictated by AB 413.

Staff seeks Council adoption of a resolution (Attachment 'A') to authorize the installation of curb markings and signage to address unsafe and illegal parking in the areas generally shown in Exhibit 'A' (Vicinity Map and Specific Location Inventory) to the resolution and in a form similar to that shown in Exhibit 'B' (example of "Daylighting" schematic / marking detail), to the resolution.

COORDINATION AND REVIEW:

This recommendation is made by the Chief of Police, Public Works Director, and City Engineer.

FISCAL IMPACT:

It is estimated that the expense for time and materials to install immediate parking safety controls is less than \$5,000 from the Streets Maintenance Fund for this initial phase of improvements.

RESOLUTION NO. 25-

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KERMAN APPROVING AND AUTHORIZING CURB MARKINGS AND NO PARKING ZONES AT PRIORITY CROSSWALKS AND CORNERS ADJACENT TO SCHOOL SITES AND OTHER LOCATIONS AS DEEMED NECESSARY FOR PEDESTRIAN SAFETY AND IN CONFORMANCE WITH AB 413, AND POSTING OF "NO PARKING AND NO TRUCK PARKING", SIGNAGE ALONG NORTH AND SOUTH SISKIYOU AVENUE AND WEST KEARNEY BLVD. IN RESIDENTIAL AREAS TO ENHANCE PUBLIC SAFETY AND CONVENIENCE

WHEREAS, the City of Kerman encourages, promotes and enforces traffic and pedestrian safety as a high priority; and

WHEREAS, the State of California has enacted AB 413, the "Daylighting Law", to increase viability at crosswalk and street corners; and

WHEREAS, the City of Kerman, despite publication and education, has experienced limited compliance with AB 413 since its passage; and

WHEREAS, curb markings are a recommended method to designate clear space around crosswalks and corners; and

WHEREAS, the City intends to initially install curb markings at high use crosswalks near school sites to enhance pedestrian and study safety; and

WHEREAS, new development now requires installation of additional "No Parking" signage to preclude heavy duty trucks from residential areas to maintain safety and peacefulness, and

WHEREAS, pursuant to Chapter 10.12 of the Kerman Municipal Code the Police Chief has reported to the Council that the public safety and convenience require the establishment of certain no parking or limited parking zones for motor vehicles on city streets; and

WHEREAS, the Public Works Director and City Engineer concur with the Police Chief's determination.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Kerman as follows:

- 1. The foregoing recitals are true and correct and incorporated by reference.
- The City Manager is hereby authorized to direct the installation of curb markings and signage as approved by this resolution and as shown in Exhibit 'A', Vicinity Map and Specific Location Inventory and Exhibit 'B', example of "Daylighting" schematic /marking detail.



Red Curb along entrance gate to proposed Dog Park #1 located at Sunset and N 6th Street.

Corners of N. 6th Street and W. Sunset

Location #6 - Residential Neighborhood (KMC)

W. Kearney (west of Siskiyou), "No Commercial Truck Parking" to western City Limits.

Location #7 - Liberty Elementary School

Red Curbs pursuant to AB 413 at crosswalks and street Corners s near heavily traveled student - pedestrian routes, including:

Corners of West E Street and S. Michele

Corners of S. Siskiyou and West E Street (two directions)

Location #8 – Kerman Junior High School

Red Curbs pursuant to AB 413 at crosswalks and street Corners s near heavily traveled student - pedestrian routes, including:

Corners of S. 1st Street and E Street

Corners of S. 1st Street and F Street

Corners of S. 1st Street and G Street

Location #9 – Kerman-Floyd Elementary School and Senior Center

Red Curbs pursuant to AB 413 at crosswalks and street Corners s near heavily traveled student - pedestrian routes, including:

Corners of 8th Street and F Street

Corners of 9th Street and F Street

Corners of F Street and S. Pacheco

Corners of West F Street and Vineland

Corners of Vineland and West E Street

Corners of Vineland and West D Street

Location #10 - Proposed Dog Park #2

Red Curb along entrance gate to proposed Dog Park #2 located at Vineland north of California Street and on eastside at 12th Street.

Location #11 - Residential Neighborhood (KMC)

Siskiyou, south of California Street, "No Truck Parking" on east and west sides, south to Railroad Crossing.
