**SUBJECT:** Agreement with Family Healing Center (SW)

**RECOMMENDATION:** Council by motion adopt resolution approving Memorandum of

Understanding with Family Healing Center.

#### **EXECUTIVE SUMMARY:**

The City of Kerman has been in agreement with the Family Healing Center for Forensic Interviews-offered on call for all needed interviews including emergency, after hours, and weekends. Children and adults that have been victims of sexual assault and domestic violence, and those who have witnessed any form of a violent crime, the Deaf and Hard of Hearing community, and developmentally delayed. These victims and witnesses may require the expert assistance offered by Family Healing Center to aid the police in successful resolution to cases. The Family Healing Center provides expert court testimony, consultation, and training to the police department for a flat fee of \$1,000.00

#### **DISCUSSION:**

The Police Department 2024-2025 Current Budget includes \$1,000.00 flat fee for services to Family Healing Center. The cost remains the same for the 2025-2026 budget.

#### **FISCAL IMPACT:**

The costs remains the same as currently budgeted.
