**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KERMAN  
APPROVING AMENDMENT NO. 3 TO AGRICULTURE LEASE AGREEMENT BETWEEN THE CITY OF  
KERMAN AND EARL L. GIACOLINI AND JANICE E. GIACOLINI (9.3 ACRES)**

WHEREAS, the City of Kerman owns approximately 9.3 acres of land (Property) outside of the City limits on land being developed as a park; and

WHEREAS, City and Earl L. Giacolini and Janice Giacolini (the Parties) entered a Lease Agreement relating to the Property on December 22, 2021; and

WHEREAS, the Parties amended and extended the Lease on November 8, 2023, by Amendment No. 1 and, on October 11, 2024, by Amendment No. 2, to extend the Lease to September 30, 2025; and

WHEREAS, the parties now wish to extend the Lease Agreement by Amendment No. 3 with all other terms and conditions to continue in effect.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Kerman as follows:

SECTION 1. The foregoing recitals are true and correct and are incorporated by reference.

SECTION 2. The City Council approves the Amendment No. 3 to the Lease Agreement with Earl L. Giacolini and Janice Giacolini, which is attached to this resolution as **Exhibit 'A'** and incorporated by reference.

SECTION 3. The City Manager is authorized to sign Amendment No. 3 to the Lease Agreement on behalf of the City.

SECTION 4. This resolution is effective upon adoption.

**AMENDMENT NO. 3 TO AGRICULTURE LEASE AGREEMENT  
BETWEEN CITY OF KERMAN AND EARL L. GIACOLINI AND JANICE E. GIACOLINI  
(9.3 ACRES)**

This Amendment No. 3 to Agriculture Lease Agreement (hereafter "Amendment No. 3") is entered into on this \_\_\_\_\_ day of \_\_\_\_\_, 2025, ("Effective Date") by and between Earl L. Giacolini and Janice Giacolini, (referred to hereinafter collectively as "Lessee"), and the City of Kerman, a public agency (hereinafter as "City" or "Lessor"), collectively referred to as "Parties."

**RECITALS**

WHEREAS, the City of Kerman owns approximately 9.3 acres of land (Property) outside of the City limits on land being developed as a park; and

WHEREAS, City and Earl L. Giacolini and Janice Giacolini entered a Lease Agreement relating to the Property on December 22, 2021; and

WHEREAS, as part of getting the Property ready for the planned park on the site, only 5.8 acres of the 9.3 acres are farmable; and

WHEREAS, the Parties amended and extended the Lease on November 8, 2023, by Amendment No. 1 and, on October 11, 2024, by Amendment No. 2, to continue the relationship; and

WHEREAS, the parties wish to extend the Lease Agreement by this Amendment No. 3.

**AGREEMENT**

**SECTION 1.** Section 3 of the Lease Agreement is amended by adding subsection 3c to read as follows.

- c. The term of the Lease Agreement shall be extended from September 30, 2024, through December 1, 2025.

**SECTION 2.** Except as amended by this Lease Amendment No. 3, all terms and conditions in the Lease Agreement shall continue in full force and effect.
