Best, Rio Pedersen Dear Councilwoman Breen, Councilwoman Hamilton, Councilman Cordovano, and Councilman Hutchinson,

We are reaching out as concerned residents of Ketchum to urge you to consider a resolution calling for a ceasefire in Gaza. Over 100 American cities and 94 members of Congress have called for a ceasefire. Last December, 153 out of 193 member states of the UN backed the resolution for a ceasefire. One year later the war is still raging on with severe humanitarian consequences, and it is time that Ketchum joins the voices of opposition to encourage current and future national leadership to end the violence. This is a non-partisan issue, and as Ketchum has always championed values of peace, justice, and respect for human rights, we believe it is important for us to join the voices calling for an end to the violence.

The ongoing situation has resulted in severe humanitarian consequences. The UN has stated that the entire Palestinian population in North Gaza is at "imminent risk of dying from disease, famine, and violence." Israel is currently blocking all aid to Gaza, leaving women and children without medical supplies, food, or water. Since October 7, 2023, 43,000 people have been killed in Gaza and many more are suffering from injury and famine. Additionally, 6,627 Israelis have been killed in the fighting. Conflict between Israel and Lebanon has resulted in the death of 2,650 people, 12,000 injured, and 80,000 people displaced. The consequences of so much death and displacement will be felt around the world. A ceasefire would not only prevent further loss of life but also allow humanitarian aid to reach those who are suffering and open pathways for diplomacy and conflict resolution.

As representatives of Ketchum, we urge you to introduce or support a resolution that aligns with our city's values and demonstrates our commitment to peace. We believe this action will send a message that our community stands in solidarity with those affected and advocates for a peaceful resolution to this crisis.

Thank you for your attention to this urgent matter, and we hope to see Ketchum take a stand for peace.

## Dear Mayor and City Council Members,

I am writing to express my concern about the increasing costs of post office box fees, which have become unaffordable for many residents. My current fee is \$194 per year, and numerous community members are feeling the burden of these rising costs.
