Mayor Bradshaw and City Councilors:

### **Recommendation To Approve Purchase Order 20651 to Machining Brokers & Associates, LLC for Submersible Pump Parts**

#### Recommendation and Summary

Staff is recommending the council approve Purchase Order 20651 and adopt the following motion:

"I move to approve Purchase Order 20651 with Machining Brokers & Associates, LLC for the purchase of submersible pump parts for the wastewater treatment plant in the amount of \$11,178.00 and authorize the mayor to sign it."

The reason for the recommendation is as follows:

- Replacement of existing equipment because of deterioration caused by age and atmosphere.

#### Introduction and History

The effluent pumping station at the treatment plant was built in 2004. The equipment in the pumping station consists of submersible pumps and piping to move water from one process to another. The pumps are routinely maintained and inspected for damage.

#### Analysis

During the last maintenance/inspection cycle, corrosion was identified on the adapters which connect the pumps to the piping to the extent that it is necessary to replace the parts before they fail and render the pumps inoperable. We have been unable to find a supplier that can sell us just the needed parts. Machining Brokers & Associates can manufacture the adapters needed for much less cost than replacing the entire piping structure in the effluent pumping station.

#### Sustainability

This purchase does not have any application regarding the Ketchum Sustainability Action Plan.

#### Financial Impact

Funds for the purchase of the pump parts will come from the Repair & Maint-Mach & Equip line item of the Wastewater Expenditures Budget and were included in the budget for FY21. This expense will be shared proportionally with the Sun Valley Water and Sewer District.
