Mayor Bradshaw and City Councilors:

Recommendation to Approve Contract 20639 with Allen Construction and Contract 20640 with Canyon Excavation for sidewalk work.

Recommendation and Summary

Staff respectfully recommends the City Council approve two separate contracts: Contract Number 20639 with Allen Construction per the attached Bid numbers dated 6/2/21 and Contract Number 20640 with Canyon Excavation per the attached Estimate number 1324 for concrete removal and replacement work using the following motion:

"I move to approve Contract Number 20639 per the attached bid numbers dated 6/2/21 and Contract Number 20640 per the attached estimate 1324 and authorize the Mayor to sign the Contracts."

Introduction and History

The Streets Department is responsible for sidewalk maintenance. We cannot complete the work ourselves due to other ongoing responsibilities. We have been contracting this work out for several years and have used both Canyon Excavation and Allen Construction with good results. Currently, Allen Construction is the only concrete contractor that can try to fit us into their schedule. Canyon Excavation has completed excavation projects for the city, including several sidewalk projects and the excavation for the street yard expansion project, also with good results.

Analysis

We have requested bids from 5 concrete contractors, Koleman Concrete, N&L Construction, Merrick Construction, Soares Builders and Allen Construction. Allen Construction and Merrick Construction are the only ones that responded, and Allen was the only one that was available to help. Their bid is attached.

We also requested bids from 4 Excavation Contractors, Joe's Backhoe, Rixon Excavation, Erwin Excavation and Canyon Excavation. We only received a response from Canyon Excavation. Their estimate is attached.

Sustainability Impact

We are not aware of any sustainability options for this project.

Financial Impact

The city has budgeted \$100,000 for sidewalk repairs in General CIP Expenditures. There is no additional financial impact.
