Mayor Bradshaw and City Councilors:

Recommendation to approve contract 20636 for fence repair with Sawtooth Wood Products

Introduction and History

Staff is recommending the council to authorize approval of the contract with Sawtooth Wood products for the repair of the chain link fence at the city's soccer field.

"I move to approve the 2021 Proposal for fence repair with Sawtooth Wood products at a not-to-exceed cost of \$5,200."

The reasons for the recommendation are as follows:

- Sawtooth Wood products was the only company providing a proposal.
- The City has had a positive experience on prior contracts with the contractor.
- FM is currently not staffed to do this work in house.
