The homeowners at Summit Ridge, including my wife Lise and I at 140 A Bird Drive, appreciate the attention the Town's Traffic Engineer has given us over the past two summers! Still, the taxpayers' investment in time and money to twice design, install and then remove the pylons and speed bumps has not been worthwhile. Intentionally creating obstructions in the roadway in hope of drivers slowing down to avoid them and hopefully avoid each other is a risky experiment. This is especially so during a peak construction phase in West Ketchum when the pavement is overwhelmed with worker vehicles and construction equipment. Let's pause during 2025, and postpone further experimentation on Bird Drive until the spring/summer of 2026. This will allow us all to observe traffic patterns and conditions along Bird during this next summer without the obstructions, and decide whether we want to reinstall them or try something else. Best to all for the holidays!
