A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KETCHUM, IDAHO, ESTABLISHING THE DATES FOR ALL REGULAR PLANNING AND ZONING COMMISSION MEETINGS FOR 2025.

WHEREAS, the City Council has determined that listing all regular meetings of the Planning and Zoning Commission to be held in 2025 would be beneficial to the residents of and visitors to the City of Ketchum.
