KURA members: is this what you think we want in the commercial core? Is it what you want? Or is it what the Ketchum exploiters want?






> Intersection of 6th & Spruce >



I am writing to voice my support of the 2nd & Washington community housing project.

I recently heard that many local business owners were against the project. I'm guessing since they are owners, they were able to take time off in the middle of the day to voice their concerns at the meeting.

Unfortunately the employees who the housing would help were most likely not able to leave in the middle of the day to attend the meeting. I hope this is taken into consideration.

I am a business owner in Stanley, but most of our employees and clients live in the Wood River Valley and I myself live in Ketchum and my business partner lives in Hailey. Many of our employees have unstable housing and/or pay a ridiculous amount of their income in rent.

While my business partner and I would love to provide housing for them, we cannot afford to do so. If my wife had not bought a house many years ago here, I would be applying to live in the new 2nd & Washington housing because I also could not afford to live here in Ketchum with the new cost of renting.

I have lived in the valley for 13 years and in Ketchum for 9 years. I have never once had to park further than 2 blocks away from where I was going. When I tell my clients who are visiting Ketchum how parking seems to be many locals' number one concern, they generally laugh and say that they have no issue with parking.

I've also heard many people (All people that do not need affordable housing) say that no one wants to live in the proposed Washington street building. While many of us would love to live in single family homes, for most people working here that is not going to happen. So is the housing perfect? No. But is it crucial for the survival of our town and to help out the workers here? Absolutely.

I think the need for community housing is much more pressing than the need for parking in our town and that without this project we will only lose more of the people who make this town function.

Thank you for all your hard work on this project, and I hope that it comes to fruition.
