17. Discussion regarding wildlife and trash in Ketchum neighborhoods (00:24:32 in video)

City Administrator Jade Riley presented short- and long-term options. Fish and Game Terry Thompson related the root cause of conflict between humans and wildlife as being unsecured trash. Wildlife resistant containers are only effective with 100% compliance. A small problem can escalate to a larger problem.

Mike Goitandia, Clear Creek Disposal, supported informational door-hangers as opposed to stickers on trash cans. He related that wildlife containers were not a problem for trash pick-up.

The Council decided to implement permanent solutions with an interim plan until containers can be obtained.
