Mayor Bradshaw and City Councilors:

Recommendation to Approve Integrated Technologies Copy / Print Service Lease Contract.

Recommendation and Summary

Staff requests Council authorize the Mayor's signature on Contract #20679 with Integrated Technologies to provide Xerox print equipment, installation and service at a cost of \$826.10 per month, or \$9,913.20 annually.

"I move to authorize the Mayor to sign the Intergrated Technologies Contract #20679, approving a monthly service payment of \$ 826.10, for copy and print equiptment and services."

The reasons for the recommendation are as follows:

- Copy and print equipment was reviewed per contract end-date with Fisher Technology in 6/2021
- RFP's were requested, vendor bids reviewed and measured against the following criteria, per Procurement policy:
 - Cost
 - Right equipment selection based on business need and use data
 - Local affiliations / reputation w/other government agencies
- Standardizing equipment across all operations
- Retiring and/or recycling old and/or un-used equipment prior to New City Hall and New Fire Station relocations

Introduction and History

Current copy and print services, provided by Fisher Technology, contracted in 5/2016, expired in 5/2021. In accordance with procurement guidelines in Idaho Code Title 67, Chapter 28, the City of Ketchum gathered bids to review copy and print services for all City locations and operations.

Analysis

Integrated Technologies, Fisher Technology and Valley Office Systems provided the City recommendations for equipment and services in pursuit of a 5-year lease / Service contract.
