Dear Mayor Bradshaw and Council Members:

Subject: E-bikes on the bike path

Dear Sirs,

I have been biking on the bike path here for 30 years now. I have never been as concerned as I am now.

Twice this summer, I have almost been hit by a child on a very large E bike.

I ride a hybrid specialized bike. If I am riding 16 to 17 miles an hour and a child 10, 12 or 14 years old flies by me therefore going at least 25 miles an hour on the bike path.... All I can ask is... if there are roads with a 25 mile an hour speed limit why are unlicensed children allowed to ride on the bike path on a machine that is going as fast as the speed limit on some roads?

Many of these E-bikes are the size of small motorcycles. And if they hit a non E- biker, there is going to be a major injury. My husband and daughter were literally almost taken out on the bike path near Sun Valley, as a child was riding, waving his arms looking around and not paying attention. Only when my husband started screaming watch out after he and my daughter had to jump off the bike path did they avoid being hit.

I almost had a child run into me at the intersection of 75 and Sun Valley Rd. What are unlicensed children doing on these bikes that are extremely powerful and extremely large. These unsupervised children on fast e bikes are an accident waiting to happen.

Someone is going to get badly hurt and it's going to be on your conscience if nobody starts policing the bike path.

As someone who loves Sun Valley and loves the recreation here I really hope you will do something about this
