Mayor Bradshaw and City Councilors:

Consideration of Alcohol Beverage License

<u>Recommendation and Summary</u> Staff is recommending council consideration of approval of an alcohol license using one of the following motions:

" Alternative 1: "I move to approve the alcohol license with the conditions set forth in the staff report

Alternative 2: "I move to approve the alcohol license with conditions consistent with the Council approved conditions of Vendor License Permit #19-101"

The reasons for the recommendation are as follows:

- Ketchum Municipal Code Requires certain licenses to sell liquor, beer or wine.
- The application is for the year 2019-20, expiring July 31, 2020, and Council approval is required to complete the process of issuing the beer and wine license.

Introduction and History

In accordance with Municipal Code 5.04.020, Alcoholic Beverage Sales, it is unlawful for any person to sell liquor, beer, or wine at retail or by the drink within the City without certain licenses as required pursuant to Ordinance 367. All City licenses for liquor, beer, and wine expire annually and require renewal by August 1st.

<u>Analysis</u>

The City has received an application from a new business for a license to sell beer and wine for both on and off-premise consumption as an off-site vendor. The applicant, Alpenglow, will be doing business in the City on a privately-owned lot (The POD, on Main Street) utilizing an off-site vendor permit. The off-site vendor permit application has previously been presented to Council.

The applicant has additionally filed for the beer and wine license and Council approval is requested to complete the process of issuing such a license. Pursuant to Ketchum Municipal Code section 5.04.060, "the council shall also have the power to impose reasonable conditions upon the operation of the business for which the license(s) is sought in order to minimize the adverse impact on public health, safety or welfare."

In order to align the vending permit conditions related to alcohol service with the alcohol license permit, staff is recommending both permits contain the same conditions for alcohol sales and service. Therefore, as presented, the alcohol permit contains the same conditions as the vending permit. Should the Council modify the vending conditions, the alcohol conditions should reflect the modifications.

Conditions of Approval:

- 1. This Licensee shall comply with all State and local liquor law requirement which among other provisions of city and state code, includes the following:
 - a. Prohibition of alcohol sales to minors;
 - b. Open container restrictions (e.g. bees poured or opened on-premises may not be consumed off-site or on public sidewalks)
- 2. Beer and wine sales by Alpenglow shall occur only when the food trucks in vending license sites 1, 3, 5, and 6 of the POD are open for business. Further, the consumption of alcohol on the POD site shall cease within 30 minutes of the last food truck closing on license sites 1, 3, 5, and 6 of the POD and, in no instance, later than 2:30AM.

Financial Impact

The City of Ketchum will realize revenue of approximately \$595.82 from approval of the license in accordance with the current fee structure. Approval may also result in additional local option tax revenue.
