AN ORDINANCE TO AMEND THE GENERAL PURPOSE SCHOOL FUND BUDGET AND THE GENERAL PROJECTS FUND BUDGET FOR THE FISCAL YEAR ENDING JUNE 30, 2025; AND TO FIX THE EFFECTIVE DATE OF THIS ORDINANCE

BE IT ORDAINED BY THE CITY OF KINGSPORT, as follows:

SECTION I. The General Purpose School Fund will be amended by increasing the estimated revenue for Other Local Revenue by \$22,804 and the estimated revenue for Unreserved Fund Balance Appropriations by \$1,074,400. The expenditure budget will be amended by increasing the appropriations for Technology, Maintenance Fees by \$50,000; by increasing the appropriation for Maintenance, Repair of Buildings by \$38,700; by increasing the appropriation for Jefferson, Capital Outlay by \$22,804; and by increasing the appropriation for Fund Transfers by \$1,074,400. The expenditure budget will be amended by decreasing the appropriation for Technology, Instructional Equipment by \$75,000; by decreasing the appropriation for Superintendents, Other Contracted Services by \$38,700. The General Project Fund budget will be amended by establishing new projects for the Robinson Gym Floor Improvements, KSC Parking Lot Improvements, and the Washington HVAC Replacement by increasing the appropriations for Architect Fees by \$314,200 and the appropriations for Construction Contracts by \$760,200.
