1. KEDB / NETWORKS Update - Craig Denison, Clay Walker

Mr. Craig Denison gave a presentation on projects that have moved forward since the last update in March. He also discussed facade redevelopment grants that have been awarded to downtown businesses, noting the success of that program. There was some discussion as he answered questions from the board.

Mr. Clay Walker discussed economic development updates and Mr. Micheal Parker provided information on several properties, including the Airport Parkway, Partnership Park III and Phipps Bend Industrial Park. Mr. Walker commented on some land under option that would be a one-billion-dollar investment and 450 high paying jobs. There was considerable discussion regarding Aerospace Park and how the industry has changed since Covid. More discussion ensued throughout as they answered questions.
