A RESOLUTION RATIFYING THE MAYOR'S SIGNATURE ON A PUBLIC SERVICE SUBRECIPIENT GRANT AGREEMENT WITH KEEP KINGSFORT BEAUTIFUL FOR COMMUNITY DEVELOPMENT BLOCK GRANT FUNDING AND AUTHORIZING THE MAYOR TO SIGN ALL OTHER DOCUMENTS NECESSARY AND PROPER TO EFFECTUATE THE PURPOSE OF THE AGREEMENT

WHEREAS, Keep Kingsport Beautiful and the City of Kingsport have historically partnered in activities which have resulted in the beautification of the city; and

WHEREAS, Keep Kingsport Beautiful desires to hold four littler pickups in the spring of 2023 across Kingsport, locations are the East Stone Drive and John B. Dennis Bypass clover leaf, Riverview Community, Downtown Kingsport, and Lynn Garden Community Center; and

WHEREAS, the city, through a Community Development Block Grant (CDBG), will provide reimbursement to Keep Kingsport Beautiful for the expenses associated with trash bags, latex gloves, trash grabbers, and safety vests; and

WHEREAS, the total investment through CDBG funding is \$1,181.20 and said funding is available in account no.: 12400006034023; and

WHEREAS, a public service subrecipient grant agreement was signed by the Mayor on March 15th, 2023 as initially Keep Kingsport Beautiful intended to host the first clean up on April 1st, 2023 and an agreement had to be in place prior to Keep Kingsport Beautiful incurring expenses for the clean-up.

Now therefore,

BE IT RESOLVED BY THE BOARD OF MAYOR AND ALDERMEN AS FOLLOWS:

SECTION I. That the public service subrecipient grant agreement between city and Keep Kingsport Beautiful for Community Development Block Grant funding is hereby ratified, including the execution of the same by Mayor, Patrick W. Shull.

SECTION II. That the mayor, or in his absence, incapacity, or failure to act, the vice-mayor, is authorized and directed to execute, in a form approved by the city attorney and subject to the requirements of Article X, Section 10 of the Charter of the City of Kingsport, is authorized to execute any other documents necessary and proper and take any and all action as may be required on the part of the city to carry out, give effect to, and consummate the transactions contemplated by the public service subrecipient grant agreement and this resolution.

SECTION III. That the mayor is authorized to execute any and all documents, including those necessary and proper, to demonstrate the city's compliance with the funding requirements relative to the Community Development Block Grant to Keep Kingsport Beautiful.

SECTION IV. That the board finds that the actions authorized by this resolution are for a public purpose including recreational and educational, and will promote the health, comfort, and prosperity of the citizens of the city.

SECTION V. That this resolution shall take effect from and after its adoption, the public welfare requiring it.
