Executive Summary:

It is recommended to appoint <u>Shelton Clark</u> to the Beverage Board fulfilling an <u>unexpired term through October 31, 2025, and to complete a full three-year term</u>.

If approved by the Board of Mayor and Aldermen, the recommended table reflects term dates. The board is comprised of nine members: Chief of Police, Director of Planning, City Recorder and six residents of Kingsport with one having at least five years' experience in business or administration in ownership or operation of retail enterprise and one licensed to practice law. Terms are three years with no term limit.
