

CITY OF KOTZEBUE RESOLUTION NO. 25-21

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KOTZEBUE AUTHORIZING THE CITY MANAGER OR HIS DESIGNEE TO PLACE AND PURCHASE ALCOHOL SUPPLIES FOR THE ARCTIC SPIRITS PACKAGE STORE FOR SHIPMENT ON THE FIRST AML BARGE OF THE SUMMER 2025 BARGE SEASON.

WHEREAS, each barge season the Arctic Spirits Package Store ("Package Store") purchases alcohol supplies for barge shipment in the summer months;

WHEREAS, these purchases must be made at this time of the year in order to make the first AML barge of the 2025 summer barge season;

WHEREAS, the Package Store Manager has reviewed CY2024 Package Store sales and prepared alcohol purchases as set out in Exhibit "A" attached hereto:

WHEREAS, these Purchase Orders # LS25-021/PO 1959 (\$81,788.85) from RNDC of Alaska, LS25-022/PO 1960 (\$92,615.15) from Odom Corporation, and LS25-023/PO 1961 (\$158,732.40) from Odom-Southern Corporation totaling \$333,136.40; and,

WHEREAS, the funding for these purchases is generated by sales at the Package Store and has been approved by the Package Store Manager, Finance Director and City Manager.

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Kotzebue, authorizes the City Manager or his Designee to place the Package Store orders as set forth herein in Exhibit "A" attached hereto.
