I'm trying to get some better submittals out of our vendor today yet. I do have his first submittal package but its pretty generic. I'm trying to avoid confusion on what we are using. If he doesn't get me something better today I'll send what I have tomorrow. As far as schedule, the filter package is still set to ship the end of August. We will do some prefab ahead of this. I would say 4 weeks from the day the filter arrives to fully install with startup happening the fifth week. It will take 2 days to receive and set the equipment in place. We will be prefabbing as much as we can ahead of time. This will begin as soon as we send in submittals on the stainless steel components and receive approval. I'm working on them now.
