



NOT EXEMPT PROPERTY  
UNDER SECTION 196.1978(3)  
(d)1.a, FLORIDA STATUTES,  
COMMONLY KNOWN AS THE  
"LIVE LOCAL ACT PROPER-  
TY TAX EXEMPTION"; PRO-  
VIDING FINDINGS OF FACT  
IN SUPPORT THEREOF;  
PROVIDING DIRECTION TO  
THE CITY CLERK; REPEAL-  
ING ALL PRIOR RESOLU-  
TIONS IN CONFLICT; AND  
PROVING AN EFFECTIVE  
DATE.**

announced during the meeting  
and that no further notice con-  
cerning the matter will be pub-

made by the City Council with  
respect to any matter consid-  
ered at its meetings or hear-

that, for such purpose, he or  
she may need to ensure that a  
verbatim record of the proceed-  
ing is made, which record in-  
cludes the testimony and evi-  
dence upon which the appeal is  
to be based.
