CITY OF LAKE CITY, FLORIDA

A RESOLUTION OF THE CITY OF LAKE CITY, FLORIDA, ADOPTING THE TENTATIVE MILLAGE RATE AND TENTATIVE LEVY OF AD VALOREM TAXES FOR FISCAL YEAR 2025 – 2026; MAKING CERTAIN FINDINGS OF FACT IN SUPPORT OF THE CITY ADOPTING SAID TENTATIVE MILLAGE RATE AND TENTATIVE LEVY OF AD VALOREM TAXES; REPEALING ALL PRIOR RESOLUTIONS IN CONFLICT; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City Council of the City of Lake City, Florida, on September 3, 2025 held a public hearing concerning the Fiscal Year 2025-2026 Tentative Millage Rates, as required by Section 200.065, Florida Statutes; and

WHEREAS, at said public hearing the City Council discussed and heard available comments offered by the public regarding the millage rate necessary to fund the budget and the specific purposes for which ad valorem tax revenues are being increased; and

WHEREAS, at said public hearing, the City Council heard available comments offered by the public regarding such proposed millage rate; and

WHEREAS, at said public hearing, the City Council allowed the general public to speak and to ask questions prior to adoption of such proposed millage rate by the City Council; now therefore

BE IT RESOLVED by the City Council of the City of Lake City, Florida:

1. ESTABLISHING MILLAGE RATE.

The tentative operating millage rate for the City of Lake City for fiscal year 2025-2026 is 4.9000 mils, which represents a 4.62% increase over the rolled-back rate of 4.6835 mils, and such tentative operating millage rate is hereby adopted.

2. HEARING FOR FINAL ADOPTION.

In accordance with Section 200.065(2), Florida Statutes, the final public hearing for the City Council of the City of Lake City to consider and adopt a final operating millage rate for fiscal year 2025-2026 for the City of Lake City shall be held on September 15, 2025 at 6 PM or as soon thereafter

as such matter can be heard.

3. NOTICE OF FINAL HEARING.

The City Clerk is directed to take all such necessary and proper action in compliance with Section 200.065(2), Florida Statutes, and any other applicable Florida Statutes to provide notice to the public of the Hearing for Final Adoption in accordance with Section 2, hereof.

4. REPEAL OF CONFLICTS.

All resolutions or parts of resolutions in conflict herewith are hereby repealed.

5. EFFECTIVE DATE.

This resolution shall take effect immediately upon its adoption by the City Council of the City of Lake City.
