City Council Resolution No. 2025-113 – A resolution of the City of Lake City, Florida, disposing of that certain parcel of real property commonly identified as the "Woman's Club of Lake City Clubhouse Property;" making certain findings of fact concerning the historic value of said real property; making certain findings of fact concerning the historic value of said real property; making certain findings concerning the powers of the City to dispose of said real property; making certain findings of fact concerning the Woman's Club of Lake City, Inc., a Florida not for profit corporation, as the entity practically and equitably best positioned to facilitate the restoration of the clubhouse located on said real property; making findings of fact concerning the surplus status of said real property; establishing and stating a municipal and public purpose to the Woman's Club of Lake City, Inc.; establishing conditions to be fulfilled before such conveyance may occur; recognizing the authority of the Mayor to execute and bind the City to such documents and instruments as are necessary and prudent to convey said real property to the Woman's Club of Lake City, Inc.; directing the

Mayor to execute and bind the City to such documents and instruments; repealing all prior resolutions in conflict; and providing an effective date.

City Attorney Martin reviewed the historical data found from his research on the building and brought forth a resolution that would conditionally authorize the Mayor to execute documents conveying the property back to the Woman's Club of Lake City, for the purpose of them facilitating the restoration and preservation of the building.
