CITY OF LAKE CITY, FLORIDA

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LAKE CITY, FLORIDA, DECLARING NORBIE RONSONET, JR. TO HAVE BEEN ELECTED CITY COUNCILMEMBER FOR DISTRICT FOURTEEN (14) IN THE AUGUST 18, 2026 MUNICIPAL ELECTION; MAKING CERTAIN FINDINGS OF FACT IN SUPPORT THEREOF; RECOGNIZING THE EXPIRATION OF SAID TERM AT THE FIRST REGULARLY SCHEDULED CITY COUNCIL MEETING FOLLOWING THE NOVEMBER 2030 STATE GENERAL ELECTION; DIRECTING THE CITY CLERK TO REFLECT SAID ELECTION AND EXPIRATION OF TERM IN SUCH RECORDS OF THE CITY AS IS NECESSARY AND PRUDENT; MAKING CERTAIN FINDINGS OF FACT IN SUPPORT OF THE CITY CLERK REFLECTING SUCH ELECTION AND EXPIRATION OF TERM IN THE RECORDS OF THE CITY; REPEALING ALL PRIOR RESOLUTIONS IN CONFLICT; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, pursuant to the provisions and requirements of the Charter of the City of Lake City, Florida, and all applicable general laws of the State of Florida, Norbie Ronsonet, Jr., properly qualified as a candidate for the seat of District Fourteen (14) Councilmember of the City of Lake City for a municipal election to be held August 18, 2026; and

WHEREAS, pursuant to Article V, Section 512 of the Charter of the City of Lake City, Florida, the City Council, acting in its capacity as the Canvassing Board for said election, at a regular meeting on Thursday, September 10, 2026, determined Norbie Ronsonet, Jr. was the prevailing candidate in the election for the District Fourteen (14) Councilmember seat of the City of Lake City; and

WHEREAS, the duly executed Certificate of the County Canvassing Board of Columbia County for the election held on August 18, 2026 and reflecting the results of such election is attached as an exhibit hereto; and

WHEREAS, as the prevailing candidate for the District Fourteen (14) Councilmember seat of the City of Lake City, Norbie Ronsonet, Jr. is entitled to be declared to be duly elected the seat of Councilmember of the City of Lake City in the August 18, 2026 municipal election; and

BE IT RESOLVED by the City Council of the City of Lake City, Florida:

1. Pursuant to the provisions of Section 509(b) of the Charter of the City of Lake City, Florida, and other applicable provisions of the general election laws of the State of Florida, Norbie Ronsonet, Jr. is hereby declared to be duly elected to the District Fourteen (14) Councilmember seat of the City of Lake City for a term of four (4) years, and pursuant to the provisions of Section 509(c) of the Charter of the City of Lake City, Florida shall assume

office at the first regularly scheduled City Council Meeting following the November 2026 Statewide General Election upon taking and subscribing an oath or affirmation required by Section 513 of the Charter of the City of Lake City, Florida.

2. The City Clerk is directed to reflect the election set forth herein for and through the period set forth herein in the official records of the City.
3. All prior resolutions of the City Council of the City of Lake City in conflict with this resolution are hereby repealed to the extent of such conflict; and
4. This resolution shall become effective and enforceable upon final passage by the City Council of the City of Lake City.
