Discussion:

Robert stated that this was tabled at the 10/17/2023 meeting. Robert stated that the applicant has provided an elevation view of the home showing what it is going to look like. Robert stated that the application meets the definition of a single-family dwelling and is permitted in the zoning district per the Land Development Regulations section 4.5. Robert introduced proof, as evidence, of the notices that went out for all three meetings.

Mr. Ford asked to hand out pictures of the home to the board. Mr. Kennon asked if he wanted it to be introduced as evidence. Mr. Ford said yes. Mr. Kennon assigned the photographs the following exhibits, the photograph of the side view of the front porch will be exhibit A, the property appraisers' worksheet will be exhibit B, the photograph of the front of the house previously provided will be exhibit C. Mr. Ford said that he added some more photographs at the request of the citizens and board. Mr. Ford stated that at the last meeting it was stated that the meeting was only to discuss the appearance of the home. Mr. Lydick addressed the citizens that being this was the Historic Preservation Agency and not the Planning and Zoning Board that we would only be discussing the appearance of the home.

We need housing, board be bullied, there are buildings in the district that do not look historic, mobile homes in the district, what the homes will look like in 30 years compared to a site built home,

the petition has been discussed at Historic Preservation meetings on September 12, 2023 and October 17, 2023, what are the design features, wants site built homes not mobile homes, just because it fits does not make it right, had to renovate home when they moved in to home 40 years ago, owns a home that needs to be fixed up, owns home that is more than a 100 years old, appreciates Board, quiet neighborhood, homes in the area have a higher roof pitch, City needs to address Dade St conditions, how can Mrs. Young say that the road has to be paved when there are roads in her district that are not paved, vinyl siding did not come out when a lot of the homes were built in the area but you have a lot of homes in the district with vinyl siding, he should be able to do what he wants with the land as long it meets the standards in the LDR, and Mrs. Hairs store does not fit the historic district standard.

Mavis Georgalis introduced documents as evidence and Mr. Kennon assigned the documents the following exhibits; exhibit D, Memo to Lake City Historic Preservation Agency, exhibit E, Florida State Statue 553.38, exhibit F, New-Manufactured Home Permit front page. Patricia Trimble read exhibits D thru F aloud to Board and citizens.

Mr. Carter stated that he walked up and down the streets in the area, but there is not a level of consistency in design standards in the area. He also stated the they need to decide what is public opinion and what is legal facts. He stated that he empathizes with the citizens, but he does not think that the Board has the right to deny this petition based on public opinion.

Mr. McMahon stated that does not like that the public is not comfortable, but he liked the additional photos that were added as this helps see what it is going to look like.

Mr. Lydick stated that he does historic preservation professional, he believes that section 10.6.6, 10.6.7, 10.6.8, or 10.6.11.2 have been meet by the applicant. He stated that he respects the opinions of Mr. Carter and Mr. McMahon but he does this for a living. He stated that the visual appearance of the structure does not conform with the district.

Mrs. McKellum stated that she owns a home in the district and that there are homes in the district that are not consistent.
