ON April 8, 2024 I received a phone call form Martha Chatmon complaining of a dead tree in her neighbors yard that is leaning towards her property. The property in question is located at 530 SE Monroe Street. I inspected the tree and deemed that the tree is dead and the bark is falling off of the tree. The tree is also infested in carpenter ants. Photos were taken and placed into the case file. A NOV was prepared and mailed certified to the owner of the property with a compliance date of April 23, 2024.

The tree is in violation of City Ordinance Sec. 104-48- Dead or diseased tree removal on private property which states: The city shall have the right to cause the removal of any dead or diseased tree(s) on private property within the city, when such trees constitute a hazard to life and property, or harbor insects or disease which constitutes a potential threat to other trees within the city. The owner of the land upon which such dead or diseased trees are standing or located shall be notified in writing by the administrator to remove such trees and the removal shall be done by said owners at the owners expense within 30 days after the date of service of such notice. In the event of failure of owners to comply with such provisions, the city shall have the authority to remove such trees and charge the cost of removal to the owner(s) of the property.
