CITY OF LAKE CITY, FLORIDA

A RESOLUTION OF THE CITY OF LAKE CITY, FLORIDA AS THE OPERATOR OF THE LAKE CITY GATEWAY AIRPORT; ACCEPTING FROM THE FLORIDA FISH AND WILDLIFE COMMISSION THE DONATION OF A SURPLUS GENERATOR PROVIDED BY THE UNITED STATES DEPARTMENT OF DEFENSE; MAKING CERTAIN FINDINGS OF FACT IN SUPPORT OF THE CITY APPROVING SAID DONATION; RECOGNIZING THE AUTHORITY OF THE MAYOR TO EXECUTE SUCH DOCUMENTS AS ARE NECESSARY TO TRANSFER OWNERSHIP OF SAID SURPLUS PROPERTY TO THE LAKE CITY GATEWAY AIRPORT; DIRECTING THE MAYOR TO EXECUTE SUCH DOCUMENTS AS ARE NECESSARY TO TRANSFER OWNERSHIP OF SAID SURPLUS PROPERTY TO THE LAKE CITY GATEWAY AIRPORT; REPEALING ALL PRIOR RESOLUTIONS IN CONFLICT; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Lake City (the "City") operates the Lake City Gateway Airport (the "Airport"); and

WHEREAS, the Florida Fish and Wildlife Commission (the "Agency") operates a hangar at the Airport; and

WHEREAS, the Agency wishes to donate a surplus Department of Defense generator (the 'Property') to the Airport; and

WHEREAS, aircraft hangar doors cannot be opened during power outages caused by storms or natural disasters; and

WHEREAS, the Property will help the Agency and other agencies open the hangar doors during power outages, allowing the aircraft to be deployed for emergency missions; and

WHEREAS, accepting the Property is in the public interest and in the interests of the City; now therefore

BE IT RESOLVED by the City Council of the City of Lake City, Florida:

1. Accepting the donated Property is in the public or community interest and for public welfare; and

2. The Mayor of the City of Lake City is the officer of the City duly designated by the City's Code of Ordinances to enforce such rules and regulations as are adopted by the City Council of the City of Lake City; and
 3. The Mayor of the City of Lake City is authorized and directed to execute on behalf of and bind the City to such documents as would transfer ownership of the Property to the City; and
 4. All prior resolutions of the City in conflict with this resolution are hereby repealed to the extent of such conflict; and
 5. This resolution shall become effective and enforceable upon final passage by the City Council of the City of Lake City.
