The Evaluation Committee Meeting for RFQ 116-2025 was held on Wednesday, August 13, 2025 at 11:30am. Present was Capital Projects Manager John Wille, Town Planner Anders Viane, Sanitation Foreman Dwayne Bell, Special Events Director Riunite Franks, CRA Administrator Allison Justice and Deputy Town Clerk Laura Weidgans. A representative from Chris Wayne & Associates was in attendance (Exhibit A).

Deputy Town Clerk Weidgans called the meeting to order at 11:31am. The Committee introduced themselves and read their scores out load for each applicant. Chair Wille submitted the scoring sheets as Exhibit B. Deputy Town Clerk Weidgans read the total scores as follows:

- 1) Chris Wayne & Associates- 437 points total
- 2) ValleyCrest- 434 points total

CRA Administrator Justice spoke about the selection process and that it was not solely based on price, but also on qualifications.

Chair Wille announced that the results would be posted shortly and that the next step would be to issue a letter of intent to negotiate.
