Summary Explanation/Background:

The Public Works Department recommends that the Town Commission approve the evaluation committee's ranking for Request for Qualifications (RFQ) #116-2025, for Specialized Landscape Maintenance Services - Park Avenue Corridor, 10th Street Corridor, Downtown Alleyways, Centennial Memorial Park, CRA Parking Lot and Bert Bostrom Park, issued on June 15, 2025, and closed on July 22, 2025.

Following the closing of the RFQ, the Town received qualification packages from the following firms:

Christ Wayne and Associates, Inc. Valleycrest

The RFQ was publicly advertised in accordance with the Town's Purchasing Code and Florida's Consultants' Competitive Negotiation Act (CCNA), Chapter 287.055, Florida Statutes. The evaluation committee reviewed and scored all submittals based on the published criteria (Attached are the Evaluation Committee Meeting Minutes, which include evaluation and scoring sheets and an overall scoring summary as calculated by the Town Clerk's office).

The final ranking is as follows:

Christ Wayne and Associates, Inc. Valleycrest

Approval of this action will authorize staff to negotiate a scope of services and fee with Christ Wayne and Associates, Inc., the top-ranked firm, for subsequent presentation to the Town Commission.
