## **RESOLUTION 03-01-23**

A RESOLUTION OF THE TOWN COMMISSION OF THE TOWN OF LAKE PARK, FLORIDA, ACKNOWLEDGING THE RECEIPT OF THE LAKE PARK 2045 MOBILITY PLAN AND MOBILITY FEE TECHNICAL REPORT AND DIRECTING THE **COMMUNITY** DEVELOPMENT **DEPARTMENT** TO **MAINTAIN** THE **TECHNICAL** REPORT IN ITS FILES AS THE SUPPORTING DATA AND ANALYSIS FOR A MOBILITY PLAN AND FEE; AND PROVIDING AN EFFECTIVE DATE.

**WHEREAS**, the Town Commission has adopted a Goal, Objectives, and Policies which provide legislative direction for the Town Manager to cause to be developed a Mobility Plan and Fee in furtherance of the public's health, safety, and general welfare; and

WHEREAS, the Town Commission has the authority to adopt and implement a Mobility Plan and Fee pursuant to its home rule authority established by the Florida Constitution and Chapter 166, Florida Statutes; and

**WHEREAS**, Mobility Pans and Fees are specifically authorized by 163.3180, Florida Statutes; and

**WHEREAS**, the Town Commission has contracted with NUE Urban Concepts, LLC, for the development of a Mobility Plan and Mobility Fee; and

**WHEREAS**, in accordance with the contract, NUE Urban Concepts, LLC has developed the Lake Park 2045 Mobility Plan and Mobility Fee Technical Report; and

**WHEREAS**, the Town Manager recommends that the Commission accept the Lake Park 2045 Mobility Plan and Mobility Fee Technical Report prepared by NUE Urban Concepts, LLC and direct that it be maintained in the Community Development Department.

**NOW, THEREFORE, BE IT RESOLVED** by the Town Commission of the Town of Lake Park, Florida

**Section 1:** The whereas clauses are incorporated herein.

<u>Section 2:</u> The Town Commission hereby directs the Town Clerk to maintain the Lake Park 2045 Mobility Plan and Mobility Fee Technical Report developed by NUE Urban Concepts, LLC, a copy of which is incorporated by reference as Exhibit "A" in the Town's official records, and that a copy be maintained in the Community Development Department.
