## **Facility Usage Agreement**

This agreement, made the
<b>Premises:</b> Town leases to Renter and Renter leases from Town the Lake Shore Park Indoor Pavilion (Facility Name)
<b>Term:</b> The hours of rental are from $\frac{9:00}{}$ o'clock $\frac{a}{}$ .m. until $\frac{1:30}{}$ o'clock $\frac{p}{}$ .m. on Tuesday, February 21, 2023 (Day/Date).
<b>Security Deposit:</b> Event organizer shall deposit with Town the sum of $\$ \frac{250.00}{}$ as security for the full and faithful performance by event organizer of all of event organizers obligations hereunder. The deposit shall be made at the time the reservation for the premise is made with Town. No interest shall be paid upon the security deposit nor shall Town be required to maintain said deposit in a segregated account. The security deposit shall not be considered prepaid rent. In the event that the event organizer shall default in the full and faithful performance of any of the terms hereof, then Town may, without notice, either retain the security deposit as liquidated damages, or Town may retain the same and apply it toward actual damages sustained by Town by reason of the default of the event organizer.
