#### **Summary Explanation/Background:**

The Public Works Department is requesting the Town Commission to consider an amendment to the Florida Department of Environmental Protection (FDEP) Agreement (No. LPA0445) about the Lake Park Lake Shore Drive Drainage Improvements Project. The proposed Amendment #1 would extend the expiration date from June 30, 2026, to December 31, 2026, and revise the approved grant work plan, project timeline, and budget details. This proposed amendment would ensure that the Town's submitted and pending invoices align with the updated deliverables required for reimbursement processing.

The Town was awarded a grant from FDEP to support a portion of the Southern Outfall Pipe Replacement Project, which included replacing an existing 72-inch corrugated aluminum pipe

with two 60-inch reinforced concrete pipes connected to the existing outfall at the Lake Worth Lagoon seawall. Additionally, the grant funded the installation of a bioswale to enhance stormwater mitigation and filtration, improving water quality entering the Lake Worth Lagoon.

Some of the proposed key revisions include:

1. Agreement expiration extended to December 31, 2026, from June 30, 2026.
2. Updated subcontracting language, including approval requirements for certain fixed price subcontracts.
3. Replacement of Attachment 3 - Grant Work Plan
4. Replacement of Attachment 5 - Special Audit Requirements
5. Replacement of Exhibit A - Progress Report Form

If approved, the revised work plan would not amend the total grant amount of \$700,000.

**RECOMMENDATION:**

I move to approve Amendment #1 to the Florida Department of Environmental Protection Agreement (No. LPA0445) about the Lake Park Lake Shore Drive Drainage Improvements Project; and authorize the Mayor to execute the Amendment and non-material administrative documents required for execution and grant reimbursement processing.
