Good afternoon Vice-Mayor and Members of the Commission,

Earlier today I sent an email notifying the Commission that Ms. Lauren Paxton had submitted an application for re-appointment to the Planning & Zoning Board. Upon close examination of the application it did not state that she wanted to be reappointed to the Planning & Zoning Board. I apologize for the error.

Ms. Lauren Paxton did submit a board membership application for consideration to the Tree Board and Centennial Celebration Committee. Each of these notifications are attached and are also available in the Commission Dropbox folder.

In order for the applications to be considered, we require a nomination from the Commission. Please let me know if you wish to nominate Ms. Paxton for one or both Board/Committee. If a nomination is received we will move the application to a Commission meeting agenda. If no nomination is received we will not move the application forward to a Commission agenda.

Please keep in mind that this means that as of May 1st, the Planning & Zoning Board will only have three (3) members. If for any reason one of those members is unavailable to attend a meeting, the Board will not be able to meet due to lack of a quorum.

Please notify those in the community that the Town is in need of Board members for the following Boards (this information is also available on the Town's website):

CRA – We are in need of one (1) members that either lives or owns a business within the CRA boundaries.

Library Board – We are in need of two (2) regular members and two (2) alternate members. The Board has not been able to meet for the past two-years because they are unable to establish a quorum.

Planning & Zoning Board – We are in need of two (2) regular members and two (2) alternate members.

Tree Board – We are in need of two (2) regular members and two (2) alternate members.

The Centennial Celebration Committee could use one (1) more member.

The need for Board members have been announced on all the social media platforms several times over the past six-months and the Town has not received any application as a result of our efforts.
