Summary Explanation/Background:

The Lake Park Community Redevelopment Agency (CRA) has identified a need to renew the current agreement with Palm Beach County Sheriff’s Office to provide law enforcement service] in the Town of Lake Park. The current Agreement (4th addendum) is expected to expire on September 30, 2025 and the proposed one-year renewal, if approved, would be effective October 1, 2025 through September 30, 2026, in the amount of \$140,700.

Note: The proposed Agreement would enable the CRA to maintain the current level of services with PBSO for special detail services within the CRA.

If approved, the Town Commission will accept Palm Beach County Sheriff's Office's negotiated hourly rate increase, including all terms, conditions, and pricing contained in the existing agreement. The Town will not expend more than the amount within the approved budget as it may be adopted or amended each year for these goods and services over the term of the contract.

Funding to support this service is presented for consideration in the proposed FY 2026 Budget. The proposed rate is requested to increase from \$116 per hour to \$132 per hour (Total annual increase from FY 2025 - \$133,680 up to FY 2026 - \$140,700).

The proposed addendum has been prepared by the Palm Beach County Sheriff's Office and reviewed by the Town's CRA Administrator, the Finance Director and the Town Attorney.

The CRA has previously worked with Palm Beach County Sheriff's Office and they have provided excellent customer service and consistent high quality services.

Recommended Motion:

I move to approve Resolution 65-09-2025 and the Amendment (Renewal) to provide Law Enforcement Services by the Palm Beach County Sheriff's Office for FY 2026, in the amount of \$140,700; and authorize the CRA Chair to execute the proposed Addendum.
