**Background and Summary**

In August 2022 the CRA Board approved a grant in the amount of \$51,000 to Bilingual Education Services. The owner and operator, Marie Raymond, has had difficulties in securing the additional resources (professors, enrollment, etc.) needed to get this operation up and running. While Town Staff has met with Ms. Raymond on multiple occasions to

provide guidance, Ms. Raymond has decided to not pursue her Bilingual Education Services venture and she notified the administration of this in November 2022. Until notification, two months rent for a total of \$2,130 was paid to Ms. Raymond pursuant to the grant agreement. Staff is recommending that the CRA absorb this expense and release the remaining funds secured as part of the previously approved grant agreement, by approving a Repeal to the Grant Agreement.
