RED, WHITE & BLUE SUNSET CELEBRATION
FIREWORKS DISPLAY**

The Town of Lake Park is seeking a qualified and experienced vendor to produce a fireworks display for our Red, White and Blue Sunset Celebration on Friday, June 26, 2026 in Kelsey Park.

SCOPE OF WORK

The Town is celebrating the nation's 250th Anniversary of Independence Day and is looking for a company to produce a fireworks display for a minimum duration of twenty (20) minutes with shells, cakes, slices and comets that range from one inch (1") to ten inches (10") in size. All replies shall include pricing for the fireworks display to be launched from the Intracoastal Waterway located on the east side of the park. There shall be no period of time from opening to the finale where there is not a display in the air. Vendor shall use one barge vessel to hold the display shells and the 2nd vessel to hold the cakes, slices and comets.

The total budget for this project is not to exceed \$34,000.00. The displays shall be turnkey operations and meet all manufacturer warranty requirements.

The selected vendor shall provide all labor, materials, and other items necessary for the pyrotechnic displays and the full cleanup of the entire area after the event. The selected vendor shall also provide certified pyro technicians and supervisors who are thoroughly familiar with the type of displays involved and the materials and technics specified.

Upon arrival at the designated location for the fireworks display, all materials shall be checked to ensure that no damage occurred during shipping and handling. Materials shall be stored in such a manner to ensure proper safety, ventilation and drainage; to prevent an unsightly appearance; and to protect against damage, weather, vandalism and theft.

INSURANCE

The selected vendor must provide proof of insurance, including general liability and worker's compensation, one month prior to the event. Insurance should name the Town of Lake Park as the certificate holder and additional insured.

AWARD

Award of contract will be based on the lowest responsive reply.

SUBMITTAL

Quotes must be clearly marked "Red, White & Blue Sunset Celebration Fireworks Display" with the Offeror's name, and address listed, and be delivered to the Town Clerk's Office at 535 Park Avenue, Lake Park, Florida 33403 or emailed to townclerk@lakeparkflorida.gov. The deadline for submission of quotes is Tuesday January 27, 2026 at 2:00 PM. Late quotes or quotes delivered to any other office other than the Town Clerk's Office will not be accepted and will be returned to sender.

The Town of Lake Park is exempt from Federal and State Taxes for tangible personal property tax.

The Town of Lake Park reserves the right to accept or reject any or all quotes, in whole or in part, with or without cause, to waive any irregularities and/or technicalities, and to award the resultant contract on such coverage and terms it deems will best serve the interest of the Town. All proposed quotes shall be guaranteed firm for 90 calendar days from Tuesday, January 27, 2026.

All Offerors are advised that the Town has not authorized the use of the Town seal by individuals or entities responding to Town requests for quotes and that any such use by unauthorized persons or entities constitutes a second-degree misdemeanor pursuant to Section 165.043, Florida Statutes.
