Summary Explanation/Background:

In accordance with the Town Charter and state law, the proposed resolution establishes the balanced annual budget for the Town of Lake Park in the amount of \$42,707,330 for the Fiscal Year (FY) beginning October 1, 2026 and ending September 30, 2027. The proposed FY 2027 Budget is comprised of the following funds:

General Fund Budget	\$ 16,708,441
Town of Lake Park CRA Fund Budget	\$ 7,711,148
Marina Enterprise Fund Budget	\$ 3,264,128
Sanitation Enterprise Fund Budget	\$ 3,560,937

Public Improvement Special Revenue Fund Budget	\$ 501,532
Special Projects Special Revenue Fund Budget	\$ 816,980

The Town Commission held three (3) budget workshops on August 10, 2026, August 19, 2026 and August 26, 2026 to discuss the proposed budget and review staff recommendations. The proposed resolution establishes the budget for the upcoming fiscal year.

Attached to the proposed resolution is a summary of proposed revenues by source and proposed expenditures by function, as they will appear in the budget summary advertisement that will be published in the Palm Beach Post on September 13, 2026, and posted on the Town's website - www.lakeparkflorida.gov - in accordance with state law.

If approved on 1st reading, the proposed FY 2027 budget resolution will be presented to the Town Commission for consideration on 2nd and final reading on Wednesday, September 16, 2025 at 6:30 p.m. in the Town Commission Chambers – Town of Lake Park Town Hall.

Fiscal Impact:

The proposed ordinance establishes the operating budget for the General Fund, Town of Lake Park CRA Fund, Marina Enterprise Fund, Stormwater Enterprise Fund, Sanitation Enterprise Fund, Insurance Internal Services Fund, Permitting Internal Services Fund, Public Improvement Special Revenue Fund and Streets and Roads Fund for the fiscal year beginning October 1, 2026 and ending September 30, 2027.
