#### **Summary Explanation/Background:**

On September 21, 2022, the Town Commission approved Resolution 65-09-22 accepting grant funding from Florida Department of Economic Opportunity (FDEO) in the amount of \$11,067,635 to support various stormwater/drainage improvements throughout the Town.

Additionally, on March 15, 2023, the Town Commission approved Resolution 26-03-23 accepting grant funding from the Florida Department of Environmental Protection (FDEP) in the amount of \$700,000 to also support various stormwater/drainage improvements throughout the Town.



On March 20, 2024, the Town Commission approved Resolution 15-03-24 to approve a construction Agreement with Foster Marine Contractors, Inc. for all stormwater/drainage projects approved under both the FDEO and the FDEP grant agreements.

As a result, the Town approved Purchase Order (PO) #00203 on April 4, 2024 to Foster Marine Contractors, Inc. to support the construction of the Town’s Southern Outfall Pipe Replacement Project in the amount of \$3,456,696.30, which was identified to be fully funded utilizing the FDEO grant funding award.

However, after review of the approved PO (following approval), staff identified that the grant funding for this project should have also included the FDEP grant funding.

Thus, the Town Commission is requested to amend the appropriation of the grant funding awards to support the Southern Outfall Pipe Replacement Project construction cost as provided within the existing Foster Marine Contractors agreement with the Town of Lake Park as follows:

Florida Department of Economic Opportunity (FDEO) Grant	\$2,750,696.30
Florida Department of Environmental Protection (FDEP) Grant	<u>\$ 700,000.00</u>
Total Project Cost	\$3,450,696.30

Note: The total cost of the Southern Outfall Pipe Replacement Project is not being requested to be changed. The only request is to reallocate the grant funding to support this important community stormwater project between two (2) separate grant funding awards.

If approved, the Public Works Department and the Finance Department will work together to amend the existing Purchase Order to provide for grant funding to be utilized for this project between both the FDEO grant the FDEP grant as provided above.

**Recommended Motion:**
