Summary Explanation/Background:

In accordance with state law, the proposed Resolution xx-xx-xx establishes increases to the Fiscal Year (FY) 2025/2026 Town Budget – Various Funds, which was adopted by the Town Commission on September 18, 2025 (Resolution 71-09-25).

The Finance Department is proposing to amend the current Fiscal Year 2025/2026 Budget to include (or reappropriate) revenue that was previously approved within the FY 2025 Budget to support various, previously approved projects and purchases that have not yet been completed.

Note: This is funding from the previously approved FY 2025 Budget that has been identified to be utilized for the completion of projects and/or purchase of capital equipment and would not be considered as new and/or additional funding above revenues/expenditures approved within the FY 2026 Budget; rather, this is being presented as funding that was existing and/or approved

within the FY 2025 Budget that has not been fully utilized. This request, if approved, would not utilize any of the FY 2026 Budget reserves and/or contingency amounts that have been approved by the Town Commission during the recent budget process.

If approved, the requested unused (encumbered), open purchase order funding from the FY 2025 Budget (previously approved revenues) will be re-encumbered into new Purchase Orders within the FY 2026 Budget, including;
