

AGREEMENT FOR THE PROVISION OF PEST CONTROL SERVICES FOR TOWN FACILITIES

THIS **AGREEMENT** (the "Agreement") is made and entered into this 17 day of December, 2025, by and between the Town of Lake Park, a municipal corporation of the State of Florida, 535 Park Avenue, Lake Park, Florida 33403 ("Town"), and Northwest Exterminating Co., LLC, 2420 North Andrews Ave Ext, Pompano Beach, FL 33064 ("Contractor").

WITNESSETH THAT

WHEREAS, the Town of Lake Park, Florida ("Town") issued Request for Quotation RFG #130-2025 on October 10, 2025 for pest control services for town facilities; and

WHEREAS, Northwest Exterminating Co., LLC submitted the only responsive and responsible quote for the total amount of \$23,580.00; and

WHEREAS, the Town Commission finds it in the best interest of the Town to enter into an agreement with Northwest Exterminating Co., LLC for pest control services for town facilities in accordance with the RFQ and the Vendor's quote; and

NOW THEREFORE, in consideration of the mutual promises contained herein, the parties agree as follows:

Scope of Services/Supply – Contractor shall provide pest control services for the following Town facilities: Town Hall, Town Library, Public Works PBSO District 10, Recreation Building, Kelsey Park West (Restroom and utility), Kelsey Park East (Pro Shop), Kelsey Park East (Pavilion), Kelsey Park East (Restroom), Lake Park Harbor Marina, and the Evergreen House, in accordance with the specifications outlined in RFQ #135-2025 and Contractor's proposal dated November 16, 2025, both of which are incorporated herein by reference.

Agreement Term and Compensation – The initial agreement will commence on December 17, 2025, and will run until December 17, 2028, with the option to renew for two (2) additional one-year terms. The Town shall pay the Contractor annually \$7,860.00. The total three (3) year term amount of \$23,580.00 is inclusive of all labor, materials, delivery, permits, taxes, and associated costs.

Licenses and Insurance – Contractor shall maintain all required licenses and insurance, including general liability, workers' compensation, and fumigation certification, during the term of this Agreement.

Compliance with Laws – Contractor shall perform all obligations in accordance with applicable federal, state, and local laws and regulations.

Termination – The Town may terminate this Agreement for cause or convenience upon written notice.

Public Records – Contractor shall comply with Chapter 119, Florida Statutes, relating to public records.
