

AGREEMENT FOR THE PURCHASE OF A 32-FOOT DOVETAIL EQUIPMENT TRAILER

THIS AGREEMENT ("Agreement") is made and entered into this 19 day of November, 2025, by and between the **Town of Lake Park**, a municipal corporation of the State of Florida, located at 535 Park Avenue, Lake Park, Florida 33403 ("Town"), and **Right Trailers, Inc.**, 7220 US Highway 98 North, Lake Land, FL. 33809 ("Vendor").

WITNESSETH THAT

WHEREAS, the Town issued Request for Quotation RFQ No. 133-2025 for the purchase of one (1) 32-foot dovetail equipment trailer with a 30,000-pound G.V.W.R. ("Equipment"); and

WHEREAS, Right Trailer Inc. submitted a quotation in response to RFQ No. 133-2025; and

WHEREAS, the Town determined that Vendor submitted the lowest, most responsive, and most responsible quotation; and

WHEREAS, the Town desires to enter into an agreement with Vendor for the purchase of the Equipment;

NOW THEREFORE, the parties, in consideration of the mutual promises and covenants contained herein, agree as follows:

1. Scope of Purchase

The Vendor shall furnish and deliver one (1) new 32-foot dovetail equipment trailer meeting or exceeding the specifications set forth in RFQ No. 133-2025 and the Vendor's submitted quotation. The Equipment shall include:

- 30,000-pound G.V.W.R.
- Dovetail configuration
- Required safety, lighting, and braking systems
- All standard manufacturer components and accessories
- Vendor shall deliver the Equipment fully assembled and ready for operational use.

2. Warranty

The Equipment shall be provided with the PJ Trailers Manufacturer's Limited Warranty, which warrants coverage against defects in materials and workmanship for a period of twelve (12) months from the date of delivery.

3. Delivery

Vendor shall deliver the Equipment to the Public Works Department located at 535 Park Avenue, Lake Park, Florida 33403, within the timeframe mutually agreed upon following execution of this Agreement.

4. Compensation

The Town shall pay Vendor a total amount of \$23,044.40 for the Equipment. Payment shall be made after delivery and inspection confirming compliance with Town specifications.

5. Public Records Compliance

Vendor shall comply with Florida's Public Records Law, Chapter 119, Florida Statutes, including all requirements applicable to contractors providing goods or services to a public agency.

6. Entire Agreement


This Agreement, including all exhibits, constitutes the entire agreement between the parties and supersedes all prior negotiations, representations, or agreements, whether written or oral.
