TITLE:

Task Order #2 with Stantec Consulting Services for Hydrogeological Consulting Services

SUMMARY:

Task Order #2 authorizes Stantec Consulting Services to provide hydrogeological services for the Wellfield Condition Assessment.

BACKGROUND AND JUSTIFICATION:

The City of Lake Worth Beach (CITY) entered into a Professional Services Agreement with Stantec Consulting Services, Inc., (CONSULTANT) on March 28, 2023, under RFQ No. 23-300. This agreement is for CONSULTANT to provide CITY with professional hydrogeological services. The purpose of this Scope of Services is to provide the CITY with professional engineering and hydrogeological services to conduct a Wellfield Condition Assessment. The objective of this task order is to evaluate the performance of the Surficial aquifer (SA) and the Floridan aquifer (FA) wells to ensure they operate efficiently and within optimal parameters. This includes identifying any decline in productivity and assessing water quality concerns, such as elevated sulfate (SO₄) levels and sand production. The assessment will generate baseline data to help identify underperforming wells and determine where maintenance, rehabilitation, or future replacement may be necessary. A total of 11 Surficial aquifer (SA) wells and 3 Floridan aquifer (FA) wells will be tested.
